The officials permitted A1 to attempt unmerited Free Throws or the officials fail to award a merited Free Throws. Which of the following is the Last opportunity officials have to correct this error?	2.10.2
In the course, of normal starting, running, or stopping, a ball passed by A2 strikes B1 in the foot/leg. The official:	4.29, 9.4
A2 ends their dribble with the left foot in contact with the playing court. A2 jumps off that foot and lands on their left foot followed by their right foot. The official rules this:	4.44.2.3
A1 is holding the ball at the free throw “elbow”. Defender B2 obtains an initial legal guarding position on A1. A1 attempts to dribble pass B2, and B2 moves obliquely to maintain their position. A1 is attempting a final Free Throw. Before the ball leaves A1 hand, B1 in a marked lane spot violates, followed by A2, who is located behind the 3 point line, comes in before the ball has made contact with the basket. The officials rules:	6.4.3c, 9.1.3f
A1 is dribbling in A’s Backcourt when the ball accidentally strikes his/her ankle and bounces away. During the interrupted dribble, A1 fouls B1 in attempting to continue the dribble. Team B is in the bonus.	4.12.2, 4.19.7
